Agenda No. 2

Prof. (Dr.) M. M. A. Faridi, Dean Emeritus, Faculty of Medicine, Era University, vide letter No. ELMC/2024/1627, dated 15.05.2024, proposed that:

- **CARE Program** for day to day revision may be instituted for the UG students of all the faculties of Era University and recommend that 20% weightage in the marks of the internal assessment may be given from CARE performance.

- **Submission of Synopsis/Research Protocol by PhD Students**

A. One week extension for submission of synopsis/research protocol by the PhD students may be given by the Vice Chancellor on the recommendation of the Dean of the respective faculty.

B. If a Ph.D. student fails to submit the synopsis/research protocol at the end of the extension period, then the late fees may be realized from the students as under:-

- Late by one week or its fraction. - Rs. 2,000/-
- Late by two weeks or its fraction. - Rs. 4,000/-
- Late by three weeks or its fraction. -Rs. 6,000/-
- Late by four weeks or its fraction. - Rs. 8,000/-
- No extension after four weeks. The duration of the PhD course will be increased by 6 months.

Resolution No. 2

Prof. (Dr.) Abbas Ali Mahdi initiated the discussions and said that 20% weightage in the marks of the internal assessment from CARE performance will be beneficial for the students at large and may be implemented and, if in any case it is objected by any governing body it may be discontinued later on. Regarding late fee charges, Prof. (Dr.) Jamal Masood proposed to reduce the late fee amount to half for all PhD students as it is too much for the students. The honorable members accepted and approved the proposal with reduction in late fee charges to half.

- *Regarding increasing qualifying criteria from 35% to 40%, Hon'ble Vice Chancellor suggested that proposal needs to be sent to respective departmental heads first then presented in the next academic council meeting after getting approval of respective Board of studies. The honorable members accepted and approved the proposal.*

In addition to above Agenda points, with permission of the Chairperson some other points were also discussed as under:

- Prof. (Dr.) Farzana Mahdi, Pro Vice Chancellor, Era University pointed out that passing marks in BMLT is 40% but in other universities it is 50% so the students of Era University do not get admission in PG course at other universities. Prof. (Dr.) Riaz Mehdi, Dean, Faculty of Allied Health Science & Research mentioned that from next semester the passing percentage will be kept at 50% after getting it approved by the Board of Studies. All members of the committee accepted and approved the proposal.
- Prof. (Dr.) Farzana Mahdi, Pro Vice Chancellor, Era University further pointed out that we are currently running Faculty Development Program (FDP) In-house and as proposals from faculties of other universities are also coming so we have started online certificate course in Health Professions Education. The curriculum has been designed by virtual universities and other international faculty and we are offering it to international faculties also. Furthermore, we are also planning to start Post Graduate Diploma in Health Education (PGDHE). The course curriculum has already been designed.



- Hon'ble Vice chancellor further mentioned that it is matter of pride for Era University that Era College of Nursing has been awarded 'A' category by UP State Medical Faculty and Era's Lucknow Medical College & Hospital has been placed at 35th position out of 880 among top medical colleges in India by India Today.
